Whereas, vide Agriculture Order No.41, 42, 43, 44, 45, 47, 48, 49, 50, 51, 52, 53 /Estt of 2016 dated: 19.02.2016, the final seniority list of various categories of officials belonging to the Department of Agriculture, Kashmir Division (Including Leh&Kargil), as on 01.01.2016 was notified; and

Whereas, after the issuance of the seniority lists a number of the officials have been promoted to the next higher grade and some have also retired on superannuation; and

Whereas, appointments to Class-IV have been made in the department of agriculture Kashmir whose names are also required to be included in the seniority lists of the concerned categories, which has necessitated updating of the seniority list and

Whereas, consequent upon the promotion / appointment of the officials of various categories in the Department of Agriculture, Kashmir, names of such officials have accordingly been reflected in the seniority lists on the basis of date of their appointment to the post/ date of their promotion to the post in accordance with the relevant provisions of Rule-24 of the J&K Civil Services (Classification, Control and Appeal) Rules, 1956; and

Whereas, some representations have been received by this directorate against the seniority position assigned /inclusion of category certificate etc, which has been examined by the committee formed by the Director Agriculture, Kashmir vide Agri/Estt/NG/2016-17/3654-60, dated: 20.03.2017, on merits of each case and as per available records, corrections wherever found necessary have been made in the seniority list; and

Whereas, it has become expedient to update the seniority lists of various categories of the officials belonging to the Department of Agriculture, Kashmir Division (including Leh&Kargil) and issuance of the same as revised.

Now, therefore, before the final seniority of all categories of posts is issued, the **Tentative Seniority list of Executive Cadre & Mechanical Staff (District / Divisional Cadre) in the pay band of S1 of Rs.4440-7440+GP 1300 upto the pay band of PB-2 of Rs. 9300-34800+GP4200)** belonging to the Department of Agriculture, Kashmir including Leh&Kargil as it stood on **01.04.2017**, are hereby notified for information of all concerned members of service for inviting objections if any, to the seniority position assigned to them, category and date of birth recorded in the relevant columns in the said seniority list, within a period of **(10) days from the issuance of this order, along with submission of valid /revalidated category certificates if any, which should be routed through proper channel along with documentary proof to substantiate the claim of any change in the seniority list by any official who may be aggrieved by the tentative seniority list.
