Sanction is hereby accorded to the release of an amount of Rs.1.26 Lacs (Rupees One Lac and Twenty Six Thousand Only) under Centrally Sponsored Scheme "Vegetable Initiative for Urban Clusters (VIUC)" funded out of CSS-Rashtriya Krishi Vikas Yojna (RKVY) out of unspent balance 2014-15 for utilization during 2015-16 for implementation of approved action plan 2014-15 and placement of the same at the disposal of Joint Director Agriculture (Inputs) Lalmandi, Srinagar as per the breakup indicated in the Annexure "A" to this order, strictly in accordance with the guidelines laid down under the scheme.

The release of funds is subject to the following conditions:-

1. The implementing officers shall implement the programme/activity/components on the cost norms/guidelines/subsidy component at par, which are admissible/permisible in the normal Centrally Sponsored Schemes implemented by the Department for RKVY Plan during 2014-15.
2. The DDO shall ensure that the funds released are utilized prudently and judiciously as per the guidelines of the scheme and in no case he should book the expenditure just for the sake of expenditure.
3. The expenditure shall be incurred only after observing all codal formalities and in accordance with the guidelines of the scheme.
4. The Implementing Officer shall restrict the expenditure to the actual availability of funds and no liability shall be created in any case.
5. The implementing officer shall ensure that there is no overlapping in funds from any other scheme of the State or Central Government to avoid duplicity of expenditure.
6. The implementing officer shall furnish progress both in physical and financial on monthly basis for its onward submission to Administrative Department.
7. The implementing agency shall send utilization certificate of funds by or before 31.03.2016.
8. The funds shall be utilized as per the approved Work Plan 2014-15.
