This arrangement shall be:-

- i. Temporary in own pay and grade and purely to look after the assignment and shall not confer any right on such officer to hold the post on substantive basis nor shall it be determinative of inter-se-seniority position of the officer.
- ii. Reversible any time without notice to any officer as may be deemed fit in the interest of administration.
- iii. Without prejudice to the outcome of the writ petition pending before any competent court of law. The officer shall be considered for regularization under rules for the higher post only on the basis of the recommendations of the DPC/PSC based on which his seniority position at the substantive level shall be determined and shall draw their salaries against their substantive posts.
