## TERMS AND CONDITION

- 1. That the offered rates must be accompanied with a CDR @ 10 % as bid security on the Minimum Reserve price pledged to Accounts Officer Directorate of Agriculture Kashmir.
- 2. That the interested party can inspect the respective grazing or harvesting area as mentioned above on any working day upto 07.05.2024 during the Office hours.
- 3. That the offered rates shall be opened on 08.05.2024 at 2.45 pm in the office chambers of Joint Director Agriculture Extension Kashmir.
- 4. That the Auction Committee shall be at liberty to accept or reject the bids without assigning any reasons thereof.
- 5. That the Successful bidders shall have to deposit 100% bid amount immediately after he/she is declared successful bidder
- 6. In case the successful bidder fails to make the payment in full within stipulated time his Bid security shall be forfeited & award of bid will be given to second highest bidder on the rates offered by Ist highest.
- 7. The successful bidder shall have to use the grazing or harvesting land without causing damage to other plantation/infrastructure of the farm.
- 8. The grazing or harvesting period is valid upto November 2024 only. In case the selected successful bidder does not show willingness for grazing within prescribed period his bid security will be forfeited besides other action initiated

including reauction of the grazing area in question at the risk of the cost of the default bidder in accordance with legal procedure.

- 9. During the auction process acceptance or rejection of bid will be announced immediately on the stroke of the hammer, if a bid is accepted earniest money. (not less than 25 % of the bid value will immediately be taken on spot from the successful bidder against proper receipt.
