Sub: Reinstatement of Mr. Bashir Ahmad Wani, AEA- transfer thereof.

- Whereas, as reported by CAO Ganderbal vide his No. CAO/Gbl/Dev/2019-20 dated 19-11-2019, Sh. Bashir Ahmad Wani, AEA has misused/ duplicated the official stamp of AEA Kurhama, Sub Division Ganderbal; and
- Whereas, taking cognizance of the report of CAO Ganderbal, Sh. Bashir Ahmad Wani, AEA was placed under suspension vide Agri. Order No. 407/Estt. of 2019 dated 23-11-2019; and
- Whereas, Sh. Idrees Bashir I/c SMS(SDL) Ganderbal was appointed as Inquiry Officer and he was directed to submit his report within a weeks time; and
- Whereas, the Inquiry Officer furnished his report vide No. No.SMS/DL/Gbl/2019-20/Camp 01-02/26-12-2019 duly endorsed by CAO Ganderbal vide his No. CAO/Gbl/Estt/2019-20/2982 dated 11-01-2020 stating therein that the charges leveled against the suspendee are not sufficient and recommended his reinstatement with transfer from his present place of posting.

Now, keeping in view the recommendations of the Inquiry Officer duly endorsed by Chief Agriculture Officer Ganderbal vide his No. CAO/Gbl/Estt/2019-20/ 2982 dated 11-01-2020, Sh. Bashir Ahmad Wani, AEA is reinstated with immediate effect and the period of suspension w.e.f. 23-11-2019 to 17-11-2019 is treated as on duty. Consequent upon his reinstatement, Sh. Bashir Ahmad Wani, AEA Zone Kurhama Sub Division Ganderbal is transferred and posted with CAO Bandipora against an available vacancy of AEA. The reinstatement of the official shall be subject to that:

1. He will not do anything in future which is unbecoming of a govt; servent;
2. He will maintain absolute integrity and devotion towards his legitimate duties.
