Whereas, it was decided in principle during various rounds of meetings held with National Horticulture Board that India International Kashmir Saffron Trading Center (IIKSTC)/Saffron Park would be handed over to the J&K Government and subsequently the inauguration of the facility had been listed in the scheduled visit of Hon'ble Prime Minister of India on 03.02.2019.

Whereas, The Facilities vi z. Collection Centre, Cold storage unit, Stigma separation unit, Quality Evaluation Lab, Drying Unit, Processing Block, Packaging Unit at India International Kashmir Saffron Trading Center/Saffron Park is complete though there are certain minor incompletions which requires immediate attention for its timely completions and subsequently Managing Director, National Horticulture Board, GoI has been requested to expedite the process of addressing these issues in a time bound manner.

Whereas, the facility (IIKSTC) has not been as yet handed over by the NHB to the J&K State Government.

Now therefore, in pursuance to the decisions taken in the review Meeting held under the Chairmanship of Administrative Secretary to Government, Agriculture Production Department, J&K on 02.04.2019 Sanction is hereby accorded to the Constitution of committee of the following Officers who would ensure completion and commissioning of India International Kashmir Saffron Trading Center (IIKSTC)/Saffron Park, Dusoo by 15th of May, 2019 failing which Administrative action shall be initiated against the delinquent officers/officials.
