Whereas, in response to the said Advertisement Notice 719 application forms were received by this Directorate and were under process of digitization etc.; and

Whereas, the said application forms were totally damaged/destroyed due to the deluge of Ist week of September 2014; and

Whereas, it has become in-avoidable to re-advertise the said posts.

In view of the above, the Advertisement Notice No: 02 of 2013 dated: 08.11.2013 issued by this Directorate shall and shall always be deemed to have been cancelled and accordingly fresh applications on prescribed format (Annexure "A") are invited from the permanent residents of Jammu and Kashmir State Kashmir Division for recruitment to the following Class-IV posts in Agriculture Department (Rakhs and Farms) Divisional Cadre Kashmir in accordance with the recruitment policy issued vide Govt. Order No: 257-F of 2011 read with SRO-332 of 2011 dated: 28.10.2011.

Terms and Conditions:

1. The pay scale of the above mentioned posts shall be 4440-7440 with Grade pay of Rs. 1300/-.
2. The candidates applying for all the posts shall have to submit separate forms for each post.
3. Age limit: The candidate applying for the post should not be less than 18 years and above 40 years of age as on 01.01.2014. However in respect of reserved category candidates (SC/ST/RBA etc.) the upper age limit shall be 43 years while for physically handicapped candidates the upper age limit shall be 42 years.
4. The candidate must possess the minimum basic qualification as Matric and maximum as 10 + 2 from any recognized Board/University. However, no additional weightage shall be given to any candidate for higher qualification in terms of SRO-99 of 2008 dated: 07.04.2008.
5. Application forms duly completed alongwith attested copies of the following documents be deposited in person or by post in the office of the undersigned upto 20.01.2015 between 10:30 A.M. to 4:00 P.M. on working days only. No application form shall be accepted after the expiry of the due date.
 - a) Date of Birth Certificate.
 - b) Academic Qualification Certificate.
 - c) Marks Certificate of each examination passed (Matric/10+2).
 - d) Permanent Resident certificate.
 - e) Category Certificate.
 - f) Recent photographs duly attested by Gazetted Officer.
6. All documents attached with the application shall be signed by the applicant and the pages numbered.
7. The total number of pages shall be mentioned by the applicant in the application form both in words and in figures.
8. Application forms found deficient in any manner or in respect of any document mentioned in the notification shall be rejected.
9. Application forms received after the due date shall not be entertained.
10. Candidates found guilty of impersonation or submitting false, fabricated and/ or tempered documents or suppressing material information shall lead to rejection of his/ her candidature at any stage besides rendering him/ herself liable for criminal prosecution.
11. Candidates will have to appear before the selection committee for interview at the venue to be intimated later on at their own expenses.
12. The date of interview shall be notified separately through print media. No call letters shall be sent to the candidates individually. However, the candidates in their own interests may contact office of the undersigned for any inquiry regarding date of interview. No claim of being un-aware of the interview date shall be entertained.
13. The candidate should be in possession of all certificates/ documents in original at the time of interview.
14. The number of posts as mentioned above, may increase or decrease depending upon the number of vacancies available at the time of final selection.
15. In case of receipt of large number of applications the candidates shall be shortlisted on the basis of merit of the candidates in the qualification.
16. The candidate should paste his/ her recent passport size photograph on the form duly attested by a Gazetted Officer.
17. Any attempt made by the candidate to influence the selection committee will result in his/ her disqualification from the recruitment process.
18. The selection of the candidates shall be made as per rules/ Guidelines issued by the competent authority from time to time.

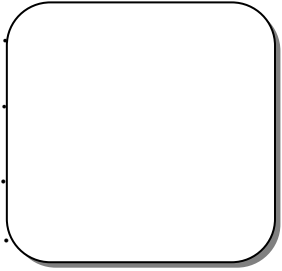
