The appointee shall be on probation for a period of two years and in case any certificate/ document during the course of verification produced by the appointee are proved to be fake or forged, the appointment shall be deemed to have been cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about the verification of his character and antecedents is received from the Inspector General of Police, CID to whom a reference shall be made by the Director Rakhs and Farms.
