

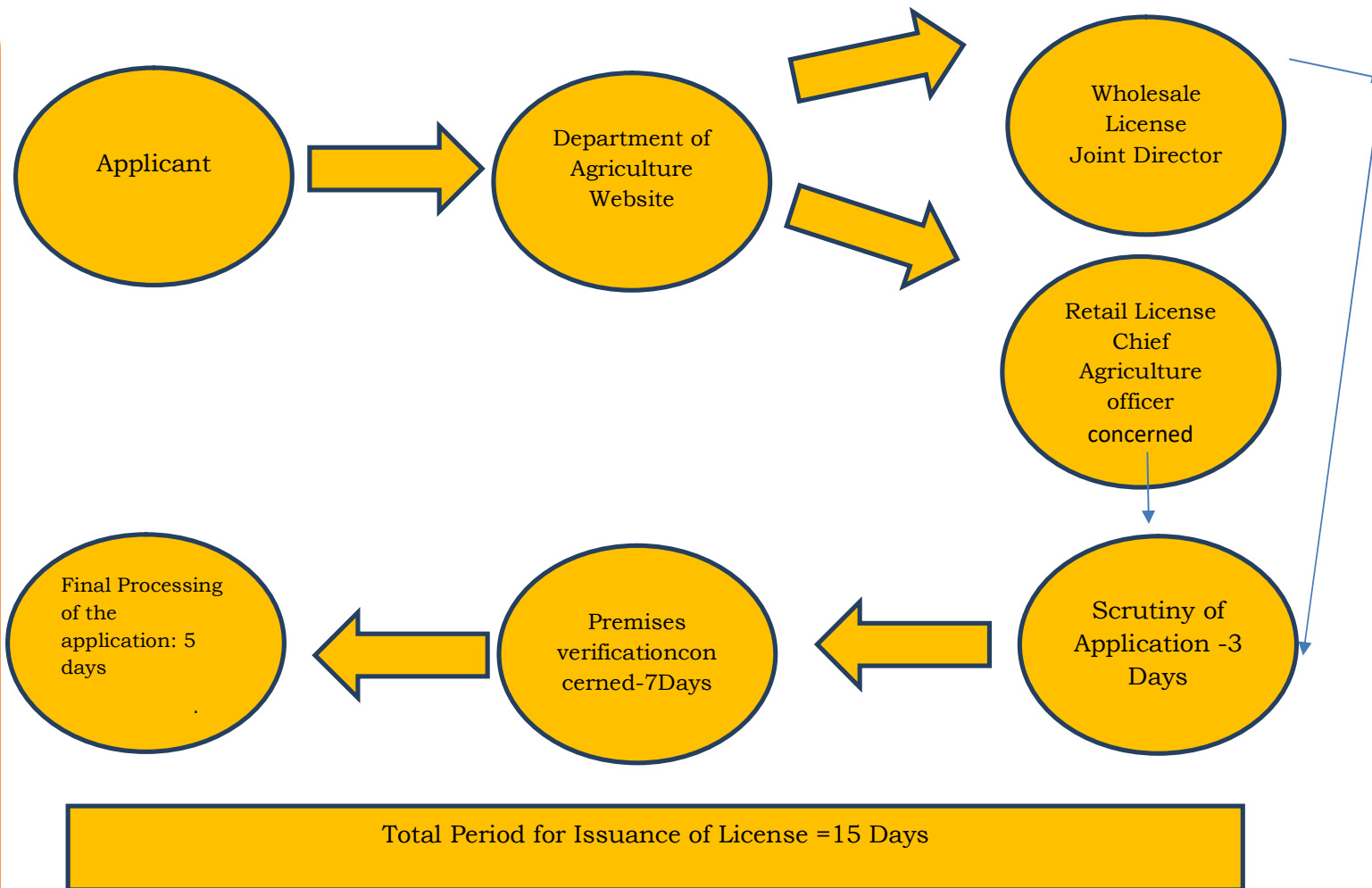
Flow chart for obtaining license for selling and storage of seeds

4. Revenue extract / Copy of Rent Deed
5. Affidavit of undertaking (Rs.10/-each) for un-employment / non-violation of seeds control order 1983. & Seed Act 1966.
6. Qualification Certificate.
7. Permanent Residence Certificate
8. Four pass port size photographs of the applicant.
9. Identity proof.
10. Post Paid Mobile Number (Android based for PoS enabling)
11. Bank Balance Certificate up Rs. 50,000/-
12. Treasury receipt of Fee for Rs.500/- under 0401 Crop Husbandry.
13. Recommendations from concerned CAO along-with requirement of seeds in the area and availability.
