- No Loan Certificate under self employment scheme from DIC and concerned Employment Department.
- Any other certificate as required under rules.

In case any certificate/ document during the course of verification produced by the appointee turns out to be fake/ fictitious, the appointment made shall be cancelled ab-initio.

The salary of the appointee shall be drawn by the concerned Drawing and Disbursing Officer only after production of Character and Antecedents Certificate from Additional Director General of Police, CID J&K to whom a request shall be made by the concerned Drawing and Disbursing Officer.


