**The release of funds is subject to the following conditions:-**

1. The implementing officer shall utilize the funds as per approved Action Plan 2014-15 under the scheme after observing all codal formalities and in consonance with the guidelines of the Scheme.
2. The expenditure shall be restricted as per the approved Action Plan and no re-appropriation/diversion of funds is allowed in any case.
3. ST/SC/ General Category farmers be covered as per the guidelines of the Scheme.
4. The DDO shall ensure that the funds released are utilized prudently and judiciously as per the guidelines of the scheme and in no case he should book the expenditure just for the sake of expenditure.
5. The expenditure shall be incurred by the Implementing Officers after observing all codal formalities as required under rules.
6. The implementing agencies shall obtain necessary sanctions from the competent authorities in advance before incurring the expenditure where-ever required.
7. The implementing officer shall ensure that there is no overlapping/duplication in adoption of Schemes/incurred of expenditure from any other scheme of the State or Central Government.
8. The release of funds shall not be taken as the final authority for utilization and the implementing officer shall satisfy himself about the techno-economic viability of the scheme/component to ensure optimum utilization of funds.

9. The implementing officer shall furnish progress both in physical and financial on monthly basis for its onward submission to Administrative Department/Government of India.
10. The implementing officer shall restrict the expenditure to the actual availability of funds and no liability shall be created in any case.
11. The implementing agency shall send utilization certificate of funds along with Physical and Financial Progress Report.
12. The amount remaining un-utilized at the close of the current financial year 2015-16 would be refunded to the Government of India.
