Subject: Appointment of candidates for the posts of Plant Protection Operator (Item No: 266, 267, 268, 269, 270, 271 & 272) Farm Supervisor & Bee Keeper (item No: 273, 274, 275) Field Supervisor (Item No: 276 & 277) Beekeeper/Field Assistant-III Equivalent (Item No 279, 280, 281, 282, 283, 284, 285, 286, 287, 288, 289 & 290), respectively-Cancellation thereof.

Whereas, J&K Service Selection Board forwarded the list of 47 candidates vide No: SSB/Secy/Sel/2022/6308-18 dated 21-10-2022 read with APDs Communication No: Agri/Cord/06/2021 dated 29-10-2022, out of which character and antecedents' verification from CID Department in respect of 04 candidates were not received leaving 43 candidates.

Whereas, and after receiving the provisional character and antecedents' verification from CID Department, appointment orders were issued to 43 selected candidates, vide different references against the post of Plant Protection Operator/Farm Supervisor/Bee-Keeper/Field Assistant in the pay level of L-2 (19900-63200). The appointment orders were issued with the condition that the appointee shall join within the period of 21 days from the date of issuance of orders failing which, the appointee shall forego the right to their appointment which shall be deemed to have been cancelled ab-initio.

Whereas out of 43 selected candidates seven candidates didn't join within stipulated time period though they were bound to join within 21 days as per the Government instructions issued from time to time otherwise, they shall loose their right for appointment without issuing any further notice and such binding has become a condition for the said appointees to seize their appointment.

Whereas, out of seven selected candidates, the appointment orders in respect of 04 selected candidates appointed during the month of October & November, 2022 under different reference were cancelled vide Agriculture Order No: 66/Esstt of 2023 dated 23-02-2023.

Whereas, following three selected candidates appointed during the month January and Febraury-2023 also didn't join and their appointment, as per rules is also liable to canceled.
