2. On completion of the course of the study, the government servant shall submit to the Directorate Agriculture, the certificate of examination passed or special course of study undertaken indicating the date of commencement and termination of the course, Certificate shall be submitted through the concerned authorities of the Sher-e-Kashmir University of Agriculture Science & technology, Kashmir.
3. The Controlling Officer/DDO concerned shall submit a copy of relieving order to this Directorate for record and reference.
4. The said course will not confer any right for preferential claim for their out of turn promotion or any other claim in contravention of rules.
