

- The appointee shall be allowed to join only after production of the following certificates (in original) to be got verified by the concerned DDO.



1. Academic/Technical qualification.
2. Matriculation /DOB certificate.
3. Health certificate from concerned Chief Medical Officer of the District.
4. No loan Certificate from District Employment Officer and Counseling Centre.
5. Relevant Category Certificate.
6. Verification of Migrant/Category/Domicile status from the competent authority.
7. The DDO concerned shall go through the provisions of Government order No: 528-JK (GAD) of 2022 before drawing the salaries of the appointee.
8. If by any chance the candidate(s) is not eligible for the post and manages to secure selection by way of presenting fake/false information which may come in the notice of the department at later stage, his/her appointment shall be liable for cancellation and criminal prosecution in light of the judgment rendered by the Hon'ble Supreme Court.
9. The appointment shall be subject to outcome of the writ petition/OA, if any, pending on the subject, and
10. The inter-se-seniority of the appointee shall be drawn in accordance with the merit secured by the appointee in the selection list prepared by J&K Services Selection Board and clarification with regard to cadre from Administrative Department.
