
Pursuant to Administrative Departments communication No: Agri/Cord/156/2021/653 dt:24.11.2021, the posting of (45) Class-IV appointees, appointed under the provisions of Jammu & Kashmir Appointment to Class-IV (Special Recruitment Rules) 2020 and joined in the Administrative Department on different dates in terms of above referred appointment orders, is hereby ordered as per annexure "A" to this order.

The DDOs shall draw their salaries only after production/authentication report of following certificates/documents from their concerned issuing authorities as required under rules.

- a. Academic/Technical qualification certificates.
- b. Date of Birth Certificates.
- c. Health certificate issued by Chief Medical Officer.
- d. Domicile Certificate issued by the competent authority.
- e. Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under the self employment scheme has been taken by the appointee.
- f. Reserved category certificate (in case of candidates belonging to reserved category).

The appointment is subject to the following conditions:

- i. If upon verification any certificate (s) produced by the appointee is proved to be fake or forged, the appointment shall be deemed to have been cancelled ab-initio.
- ii. The appointment of the said candidates shall be governed by the J&K Probationer (Condition of Service, pay and allowance) and Fixation of Tennure Rules, 2020 notified vide S. O. 192 of 2020 dated 17 -06-2020.



- iii. The appointment shall be cancelled ab-initio, if it is found that the candidate(s) possess higher qualification than the prescribed one at any stage and he/she shall also be liable for action under Law.
- iv. The appointee (s) shall be on probation for a period of two years.
- v. The inter-se seniority of the appointee (s) shall be drawn in accordance with the merit secured by the appointees in the selection list prepared by the J&K SSB.
- vi. The appointment of the said candidates shall be governed by "New Pension Scheme" as per SRO 400 of 2009 dated 24-12-2009.
- vii. The appointment of the candidate is subject to outcome of any writ petitions(s)/OA pending before any Court of Competent jurisdiction, therefore a fresh undertaking duly attested by the Ist Class Judicial Magistrate be obtained from each appointee to the effect that in case of any adverse report is to be received from any court of law is accepted by the appointee before releasing their salaries in their favour.
- viii. In view of the provisional security clearance received from the CID, the appointee shall give an undertaking in the prescribed format forming annexure "B" to this order and in the event of any adverse report received from the CID, subsequently, the appointment of the appointee shall be deemed to have been cancelled ab-initio.


