Whereas, after receiving the provisional character and antecedents verification in respect of 43 candidates from CID Department, appointment orders have been issued to 43 selected candidates vide different references.

Whereas, the Character and antecedents verification in respect of remaining 04 candidates from CID Department has not been received by this Directorate as yet;

Whereas, out of these 43 selected candidates, 07 selected candidates, did not join this Department within stipulated time period of 21 days, therefore, their appointment order for the post of Plant Protection Operator/Farm Supervisor/Bee-Keeper/Field Assistant in the pay level L-2 (19900-63200) were liable for cancellation as per the rules and conditions laid down in the appointment orders and accordingly their appointment orders were cancelled vide Agriculture Order No. 66/Estt of 2023 dated 23-02-2023.

Whereas, as per sub rule 7 of rule 14 of J&K Civil Services Decentralization & Recruitment Rules-2010 notified vide SRO 375 of 2010 waiting list is to be operated, and the next selected candidate (s) is to be called for further course of action

Whereas, Agriculture Production Department vide communication No. Agri-Cord/06/2021 (CC7091749) dated 11-04-2023 accorded approval for operating waiting list.

Whereas, notices were issued from time to time among the waiting list candidates as per selection list vide this office No: Agri/Estt/NG/2022-23/1553-54 dated 10.06.2023, No: Agri/Estt/NG/2023-24/1764-65 dated 24.06.2023 and No: Agri/Estt/NG/2023-24/2155-56 dated 22.07.2023 respectively for filling up of these (07) posts.

Whereas, (06) candidates have submitted their requisite certificates as required under rules before this Directorate and simultaneously this formal appointment orders have been issued in their favour.
