

It is to apprise that some unscrupulous/ anti-social elements have been found involved in duping/ deceiving the un-employed youth by issuing fake appointment orders in their favour which is a matter of grave concern, as such I am directed to request you to kindly take up the investigation in the instant matter so that the culprits are brought to book. The said fake order is enclosed for your perusal. This letter may be treated as a request to lodge an F.I.R. against the unknown culprit to investigate the instant matter.

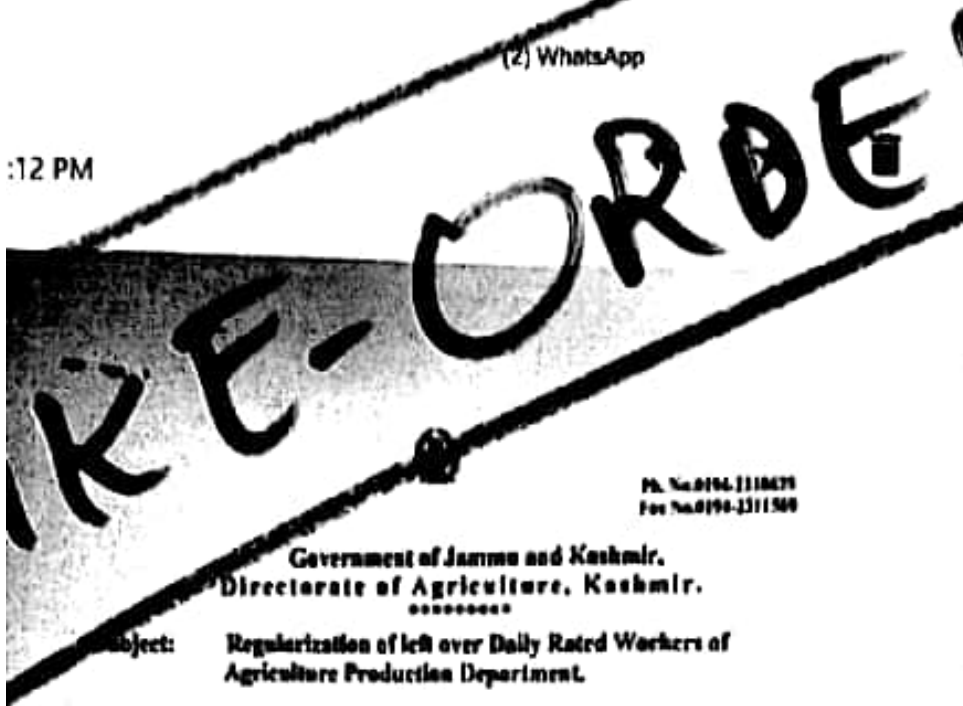

Whereas, Administrative Department vide Govt. Order No. 165-Agr of 2013, dated: 13.05.2013 constituted a committee of following officers wherein Sh. M. S. Kano the then I/C Director Law Enforcement, Srinagar was appointed as Convener of the committee to ascertain the genuineness of the drop out DRWs of Agriculture Department who were claiming to have been engaged before the ban period imposed by the govt. viz: 31.03.1994.

Whereas, the constituted committee submitted its 1st report where under (121) Daily Rated Workers were identified for regularization. But the said report was submitted directly to the Administrative Department by the committee without the knowledge of this Directorate.

Whereas, Administrative Department forwarded the said list of Daily Rated Workers to this Directorate and sought the detailed information in respect of these (121) Daily Rated Workers through medium of various communications which are on records to substantiate the findings of the constituted committee viz: Initial engagement orders, wages drawal statement, Continuity Certificates, history sheets etc. and accordingly this office sought required information from the concerned Controlling Officers/ Drawing and Disbursing Officers for submission to the Agriculture Production Department.

Whereas, the concerned Controlling Officers/ Drawing and Disbursing Officers submitted the requisite information as sought by the Agriculture Production Department which was forwarded to the Agriculture Production Department vide No: Agr/VE/NC/2014-15/2349, dated: 01.08.2014 as it was received by this office.

Whereas, 3rd Empowered Committee meeting was held on 05.01.2016, and accordingly the Administrative department vide their No: Agr/NC/DRW/7/2015.

10. The Concerned Controlling Officers shall allow above named regularized Daily Rated Workers to join against newly created posts of helpers only after satisfying themselves that all basic records required for regularization under BRD-44 of 1994 corroborate with terms and conditions as laid down in Govt. Order No: 23-Agr of 2019, dated: 23.01.2019 and should have relevance with material and documentary records being maintained in your office and any deceit in the matter shall be the personal responsibility of the concerned DDO and this office shall not own any responsibility in this regard. Therefore defaulting Controlling Officers/ Drawing and Disbursing Officers also shall be dealt under the provisions of Civil Services Regulation/ Classification Systems Control and Appeal Rules governing the deceit in Public Administration Systems wherein every Officer Official is required to maintain absolute honesty, integrity and diligence while disposing off matters of public interest.

However, the instant order as and when desired by any investigating agency viz: VOK, Crime Branch or any credible investigating institution who are desirous to hold an enquiry/ investigation in respect of regularization of these (40) Daily Rated Workers regularized vide Govt. Order No: 23-Agr of 2019, dated: 23.01.2019 and if any discrepancy/ default is reported during the process of regularization of (40) Daily Rated Workers at any point of time, the regularization order shall cease to have any effect as being issued by this office which otherwise is issued in compliance to the Govt. Order issued under No: 23-Agr of 2019, dated: 23.01.2019. This office shall not own any discrepancy which leads to the regularization of Daily Rated Workers as Helpers which has been recommended to Govt. purely on your recommendations. The regularization of such Daily Rated Worker under these circumstances as mentioned above shall be deemed to have been cancelled ab-initio and the defaulting Officers orchestrating the fraud/ default in manipulating records shall be liable for criminal action as envisaged under rules.
